NTDC manages 16 publicly funded programmes in partnership with a range of Government Departments and Agencies. The Company is governed by a Board of twelve Directors and employees over 65 staff and 220 participants through employment programmes. Board & Membership

North Tipperary Development Company (NTDC) strives to meet the best governance standards driven by the principles of transparency, openness, and accountability. NTDC is a company limited by guarantee with charitable status. The Board of Directors are the ultimate decision-making body within the organisation. The Board includes representatives from the community and voluntary sector, public representatives, social partners, and statutory agencies to devise and implement solutions to social exclusion and local development needs in North Tipperary.

In addition to an annual independent financial audit, NTDC is subject to internal audits by each funder. The Board is committed to adopting the Principals of the Charities Governance Code. Prior to the Charity Regulator Governance Code, NTDC complied with the voluntary code of governance for community, voluntary and charitable organisations.

The Board met 10 times in 2021. It performs its functions both directly and through the operation of specific sub committees in accordance with their approved terms of reference. Sub Committees include Finance, Audit, Executive, Project, Nomination and Governance/Compliance. During the year, the Board carried out a skills audit report that will help inform future Board recruitment. The Board currently comprises of 12 members and outlined in the table below.

Overview of NTDC

'NTDC Developing Individuals, Communities and Opportunities in North Tipperary and Beyond'

North Tipperary Development Company (NTDC) is a not for profit, community focused local development organisation, providing a wide range of services in North Tipperary. NTDC assists individuals and communities to enhance their quality of life through a range of supports including rural enterprise, social inclusion, economic development, employment, energy and community development.

The company operates within the Nenagh and Thurles Municipal District Areas. It came into operation on 1st January 2009 as North Tipperary LEADER Partnership Company (NTLP). NTLP was an amalgamation of the programmes and activities of Roscrea 2000 Ltd, Nenagh Community Network, Tipperary LEADER Group and Thurles Action Community Development, which was called for at the time by the Department of Community, Rural and Gaeltacht Affairs (DCRGA). In 2018, through a rebranding process the company was renamed North Tipperary Development Company to reflect its overall work as a development company.

The unique approach of NTDC is bottom-up, community-led, close to the point of delivery and above all, developmental. It is in full harmony with the key aspects of the 12 programmes which it implements

This theme is a key focus for national government and NTDC are concentrated on backing promoters interested in availing of funding for projects centred on protecting Water Resources and Local Biodiversity or developing renewable energy projects.

Our Enterprise & Employment pillar supports those wishing to start or expand a business and also supports clients to prepare for and find employment.

Our Developing Opportunities pillar will see NTDC developing new opportunities for the county to meet emerging challenges and trends. The Rural Regeneration and Development Fund and other funding streams will be targeted for much-needed project funding and the organisation will engage with emerging statutory frameworks such as the National Social Enterprise Strategy and the Community Development Strategy and the EU Smart Villages initiative.





Tús Programme


The Tús Programme is a 12-month community work placement initiative based on a 19 1/2 hours flexible week, with training available to participants. Working opportunities are available in a variety of roles: social care of all age groups, caretaking and supervising of community buildings/facilities, community administration, community event management, work in heritage and cultural activities, energy conservation work in homes and community buildings and charity shops.

During 2021 our 165 participants have worked in 140 host communities such as Tidy Towns, Creches, Day Care Facilities and National Schools to name but a few.



ECCE:

The Early Childhood Care and Education
Programme (ECCE) programme is a universal
two-year pre-school programme available to all
children within the eligible age range. It provides
children with their first formal experience of
early learning prior to commencing primary
school. The programme is provided for three
hours per day, five days per week over 38 weeks
per year and the programme year runs from
September to June each year.

National Childcare Scheme:

The National Childcare Scheme (NCS) helps parents to meet childcare costs.

The scheme provides 2 types of childcare subsidy for children over 6 months of age:

- A universal subsidy for children up to 15yrs old. It is not means tested.
- An income-assessed subsidy for children up to 15yrs old. It is means tested.

First Steps Preschool & Afterschool

First Steps, Roscrea is open 51 weeks a year 8am- 5.30pm. Offer Full time, Part Time, sessional and half sessional.

CCSP:

The Community Childcare Subvention Plus (CCSP) programme helps disadvantaged parents and parents in training, education or low-paid employment to get childcare at reduced rates. NCS has replaced this programme and is closed to new parents. However any Parent who was on it before NCS can remain on it.

We also provide Breakfast, lunch and dinner.
All meals are cooked on site.





Traveller Project

The Primary Healthcare Project

The Primary Healthcare Project is a peer led service providing primary healthcare services to the Traveller Community. The project provides appropriate and accessible health information on priority health issues, while addressing any Traveller health inequalities with the support of the HSE. Currently the programme has two primary health care teams in Roscrea and Thurles.

The event was organised by North Tipperary **Development Company** in conjunction with the Local Development Companies of Offaly, Clare, West Limerick, and South Tipperary (STDC). The event was attended by Sheds from Tipperary, Offaly, Clare, Limerick a nd beyond.



The event provided a perfect opportunity for members of Men's Sheds to meet, network, share information and learn from each other. The day started with a tour of Thurles Men's Shed, which is somewhat unique among Sheds in that it is a purpose-built facility. The group then continued to Cabragh Wetlands (Thurles) for outdoor music, food & talks.

NTDC were proud to support The Lunch Bag with a LEADER grant award to support the establishment of their new business at Lisbunny Industrial Estate, Nenagh. The LEADER Grant was awarded under the Rural Development Programme 2014-2020, under the aegis of the Tipperary Local Development Committee and administered through North Tipperary Development Company.

NTDC Thurles Premises Upgrade

The Board of North Tipperary Development Company have welcomed the €140,000 LEADER grant towards the refurbishment and upgrade of their Kickham Street Thurles premises to allow for the development and expansion of their community facilities, resources and services in Thurles and its surrounding areas. The Grant has been provided though the Tipperary County Council's administered Tipperary Local Community Development Committee (LCDC) under the 2014 – 2020 Rural Development Programme (LEADER)



The Grant is part of an overall project expenditure of €190,000 and will allow for the conversion of the builidng's first floor from residential to office and administration accommodation, upgrade and create community and youth meeting, training and resource facilities and provide for a general energy upgrade of the building.

This refurbishment has a large energy retrofit element of the project in line with NTDC's lead role in developments in the energy area and with NTDC's recent commitment to become a Sustainable Energy Community (SEC).

NTDC Purchase of an Electric Van

North Tipperary Development Company (NTDC) in partnership with NTDC Tús and NTDC Rural Social Scheme (RSS) have announced the purchase of an electric vehicle and the installation of an electric vehicle charging point at their Nenagh Office. NTDC wanted a sustainable, costeffective and environmentally friendly alternative to the diesel van currently being used to facilitate the delivery of their employment support programmes. The new van provides NTDC with the perfect sustainable solution at a greatly reduced cost of ownership. The installation of an electric charging point at the Nenagh Office will allow electric



vehicles to be fully charged, from zero to 100%, in 7 hours on average. There are also cost benefits for the projects supported by the vehicle".

The electrification of transport is a key part of North Tipperary Development Company's Strategic Plan and our sustainability goals. NTDC aims to become a leader in the green economy and sustainable communities in a local development context.
